Elective Subjects: HINDI, PHYSICS, CHEMISTRY, BIOLOGYA, MATHEMATICS,
HISTORY, GEOGRAPHY, SOCIOLOGY, COMPUTER SCIENCE &
PHYSICAL EDUCATION.

The sanction is subject to the fulfillment of the following conditions, in addition to the general conditions intimated at the time of grant of affiliation for secondary classes:

1. The school will provide additional suitable facilities for classes XI and XII, as per requirements.
2. It will increase the number of books in the Library and equipments in the Laboratories/Workshops with adequate games facilities etc. in consonance with the requirements of the Board for Classes XI & XII.
3. The school must follow Uniform System of Assessment, Examination and Report Card for classes VI-IX from Academic Year 2017-18 onwards as per the Board's Circular No:Acad-14/2017, dated 21.03.2017.
4. The school must submit it's information through Online Affiliated School Information System (OASIS) as per the Board's Circular No:CBSE/Aff./4/Circular/2016, dated 10.11.2016, within 30 days from the receipt of this grant letter. Link for OASIS is available on Board's website:www.cbse.nic.in.
5. It will appoint only qualified staff to teach Classes XI & XII as per requirements laid down by the Board.
6. It will provide for adequate co-curricular and extra-curricular activities for the wholesome development of the students.
7. It will abide itself by the Affiliation Bye Laws of the Board and other rules and regulations prescribed by the Board from time to time.

will continue to pay an Annual Fee of Rs. 3000/- p.a. The schools run by KV/ KVS/ NVS/ Army/Navy/Air Force/Military/ Govt./Govt. Aided/Sainik/Railway/Atomic Energy etc. are granted regular affiliation and these schools have been advised to remit prescribed annual fee by D.D. in favour of Secretary, CBSE, payable at Delhi. This may be complied in future.

Annual fee has been received for the session 2021-22.
The school is required to contact the concerned Regional Office of CBSE for allotment of school number and password for online Registration of candidates
Special conditions to be complied within 01 month:-

- i) The school is required to appoint Special Educator as per rule 13(11) of Affiliation Bye Laws of the Board and as mentioned in Board circular dated 25/06/2015.
- ii) The School is required to follow the safety guidelines as issued by the Board vide Circular No.-19/2017, dated 12/09/2017 captioned "Safety of Children in Schools".
- iii) The school is required to submit the copy of fee structure of the school.
- iv) Number of books in the library is less than the minimum prescribed limit and therefore library should be enriched with at least 05 books per child subject to a minimum of 1500 books.
